## Feedback to Learner

**Research and creative imagination**: Design submission did not show research of precedents / case studies. The site planning shows some creativity in the planning, however overall building form lacks creative input and does not move beyond an extrusion of the plan.

**Form and spatial design**: The unit plans a largely thoughtful – however social spaces should be grouped (eg living / kitchen / lounge) at the northern edge of the apartment – kitchen should not be completely internal with no access to natural light. Roof plans have been considered and show a planning intent.

**Site analysis and site planning**: Site analysis is at a functional level but poorly communicated with micro diagrams and micro-micro text. The site planning is quite pleasing without being inspired and the graphics are pleasing. There is limited explanation as to why the site is planned as it is.

**Application of building and environmental services**: Construction detailing is not sufficient for a Masters level. Drawing is not set out clearly and does not depict all elements required for this subject. Environment systems are generic and diagrammatic – they do not accurately represent actual site

conditions or responses.

**Application of heritage, socio-cultural and community values**: There no evidence of the student understanding or responding to the adjacent uses eg the Avalon, the park, the retail area, the neighbouring units, the traffic, the river, adjacent architecture etc.

**First Nations voices and designing on Country**: Unbalanced with excessive hard surfaces. No evident research. Design does not integrate design principles and mis-applies designs as an artistic overlay.

**Presentation**: Elevations should not be shown grouped – they appear as a single elevation. No line weight definition and material depiction is unclear / not consistent or complete. Sections do not accurately depict the site conditions. Graphic quality of the plans is sufficient.
